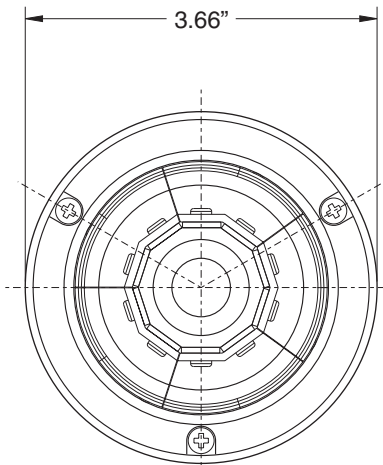
- **Long Life** - The solid-state LED light source has shown conservative lab life results of greater than 20,000 hours
- **Vibration Resistant** - There are three distinct benefits
 - a) The LED light source does not have a fragile filament like a lamp, or a gas filled glass envelope like a strobe flash tube
 - b) There are no heavy capacitors or transformers associated with strobe power supplies
 - c) The hardcoated polycarbonate dome is a simple non-optic part that is molded in one piece. It will not have any molded in stress associated with the two part optic dome. Also the one-piece construction makes it much less susceptible to environmental or chemical breakdown
- **RFI** - No EMI or RFI
- **Lower Power** - Average current draw is 0.4 Amps @ 28V. No inrush current that is inherent with strobe power supplies and halogen flashers
- **Less Weight** - The combined weight of two 7090502 LED beacons is less than the combined weight of strobe power supply, and two strobe beacons
- **Visibility** - The LED approach yields the "best of both worlds". Crisp on and off cycles compared to a halogen or rotor, and longer on time compared to a strobe
- **Reflection** - Will not produce the same reflections as strobe. If needed, the inside of the lens can be masked
- **Mounting** - Units will mount using existing mounting configuration without altering aircraft
- **Quality & Mfg.** - Whelen manufactures and packages all LED products at their facility eliminating costly handling and shipping for different mfg. processes. Utilizing automated machinery for the high volume automotive division, the aviation division is able to capitalize on cost effective mfg. techniques for low volume aviation product runs

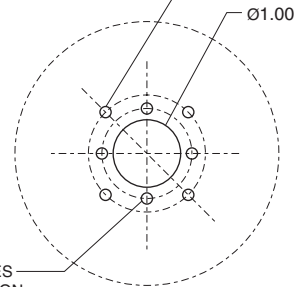

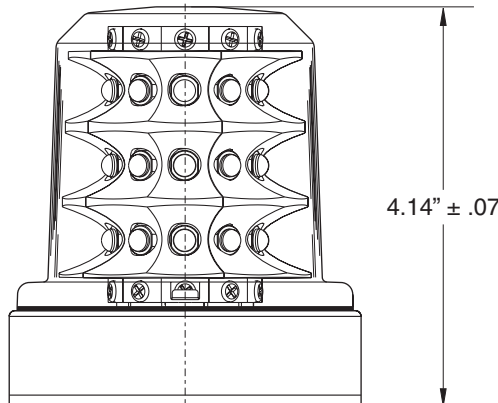


4x#6-32 MTG HOLES

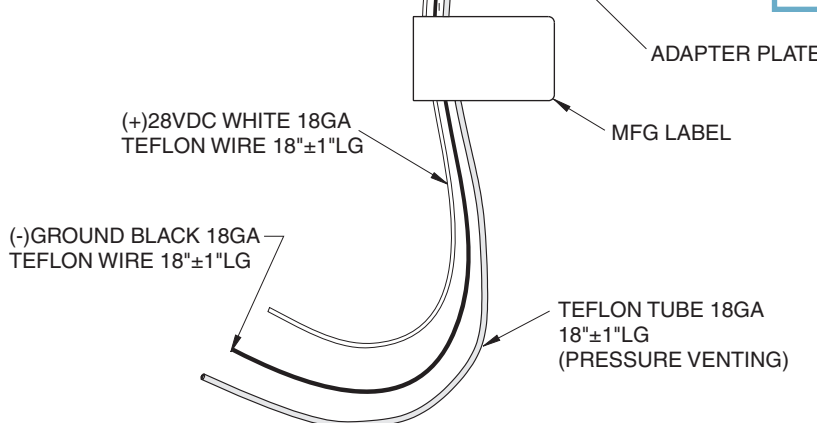
